



# 1. Quoted Price:

- a) The Bidder shall quote unit rate which shall comprise of monthly remuneration, OTA rate, EPF, ESI & other statutory costs and Service charges (including profit and administrative charges) in the format of quotation attached only (Annexure A to D). The rate quoted shall be fixed for the duration of the contract and shall not be subject to adjustment except the statutory provisions, if amended. In case of change in rate due to statutory provisions, only such change will be accepted and not any additional liability i.e. % age of profit / service charges etc. As such, the bidder while submitting the bid should specifically, quote the rate etc. in this regard. (Monthly remuneration will be 30 days for the security and 25 days for the other services for comparative statement purpose)
- b) The service tax is exempted vide Circular No.172/7/2013 ST by Govt. of India for education institutions.
- c) Correction if any shall be made by crossing out, initialing, dating and rewriting.
- d) Bidder shall deposit Rs.30,000/- (Rupees Thirty thousand only) for Security Services, conservancy Services, Gardening Services and Data entry operator deployment services as Earnest Money Deposit (EMD) in the form of Demand Draft drawn in favor of "KV EME VVN A/C" payable at Vadodara along with the bid. Bid securities of the unsuccessful bidders should be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30<sup>th</sup> day after the award of the contract.
- e) Each Bidder must submit only one quotation for each service separately.
- The tender shall be accepted under Bid System. The interested Service Providers are advised to submit Technical & Financial bids in sealed envelopes superscribing
   "TECHNICAL/FINANCIAL BID FOR PROVIDING SECURITY / HOUSEKEEPING/ GARDENING / DATA ENTRY OPERATOR DEPLOYMENT SERVICES" to Kendriya Vidyalaya No.2 EME, Vadodara.
- 3. The successful tenderer will have to deposit performance security in the form of **D.D.** for an amount equivalent to **5%** of the net amount for one year. The performance security shall be submitted within 10 days from the date of Notification of Award. The performance security will be retained for a period of **90** (**ninety**) **days** beyond the date of cessation of the contract (initial one year) for completion of all contractual obligations of the bidder including warranty obligations and till providing the NOC from all the employees about the settling of their dues. In case, the contract is further extended beyond the initial period, the performance security will have to be accordingly renewed by the successful tenderer as per new labour rates and will be returned as per the condition stated above.
- 4. <u>Conditional bids shall not be considered and will be out rightly rejected.</u>
- 5. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the **Financial Bid Form**. In no case should there be any change in the format of the financial bid. In such cases, the tender shall be summarily rejected. However, the cuttings, if any, in the **Technical Bid Application**, the same must be attested by the person authorized to sign the tender bids.
- 6. In case of partnership firms, a copy of the partnership agreement, or general power of attorney duly attested by a Notary Public, should be furnished on stamped paper duly sworn or affirmed by all the partners admitting execution of the partnership agreement or the general power of attorney. The attested copy of the **CERTIFICATE OF REGISTRATION** of firm should also be

enclosed along with the tender along with the name of authorized partner to interact with **Kendriya Vidyalaya No.2 EME, Vadodara**.

- 7. Each page of the tender document as well as annexure should be signed by the tenderer or by authorized signatories with seal of the firm.
- 8. The TECHNICAL & FINANCIAL BID shall be opened on the scheduled date and time (At 12.00 hrs on <u>17-September-2019</u>) in the Vidyalaya in the presence of the representatives of the Agency / firm if any, who wish to be present at the time of opening the tender.
- 9. The TECHNICAL BID if not qualified will be summarily rejected.
- 10. The bidding firm has to give a self-certified certificate that it has not been blacklisted by any Central Government Department/ State Govt./ Autonomous Body/ PSUs/ Banks, etc. If it is subsequently found out that the bidding firm has given false information or facts or has suppressed facts or manipulated the documents, etc, the earnest money/ Security Deposit of the firm/ Agency will be forfeited and the bid/contract will be rejected/ cancelled.
- 11. No bidding firm will be allowed to withdraw its bids. If any firm intends to withdraw opening of technical bids, it's Earnest Money (EMD) will be forfeited.
- 12. If after award of the contract, the successful bidder (L1) fails to provide required number of Security Guard / Gardner / Conservancy /Data Entry operator, the contract is liable to be cancelled along with forfeiture of SECURITY DEPOSIT and other consequential actions such as blacklisting, as deemed appropriate.
- 13. Telex, Email or Facsimile Bids are not acceptable.
- 14. The lowest bidder will be selected on the basis of rates, all categories (Security, Conservancy, Gardening & Data Entry operator) put together as per requirement.
- 15. The Bid shall remain valid for a period not less than 120 days after the deadline fixed for submission of Bids.
- 16. If there is tie in the L1 Vendor the evaluation will be done on the basis of technical bid qualification.

a) The Indenter will award the contract to the bidder whose Bid has been determined to be substantially responsive and who has offered the lowest price for all services put together. The indenter will prefer the bidder who is bidding for all the services together.

- b) The Indenter reserves the right at the time of award of contract to increase or decrease the requirement of manpower indicated in para 2 above.
- c) The indenter prior to the expiration of the Bid validity period will notify the bidder whose Bid is accepted for the award of contract. The terms of the accepted offer shall be incorporated in the contract.
- d) Notwithstanding the above, the Indenter reserves the right to accept or reject all Bids and to cancel the biding process and reject all Bids at any time prior to the award of the contract.
- e) The contract awarded shall be valid for a period of one year from the date of awarding of the contract, which can be extended for such period as may be decided by the Principal, Kendriya Vidyalaya No.2 EME, Vadodara but not more than one year after review of performance.

- 18. The contract can be short closed without any prior notice on account of unsatisfactory services upon performance review by the Authority of **Kendriya Vidyalaya No.2 EME**, **Vadodara**. The unsatisfactory service shall mean and include non-compliance and non-fulfilment of any of the contractual obligations by the Service Provider and or poor performance and violation of any of the terms and conditions of the tender/contract and failure on its part to correct the discrepancies/shortcomings brought to its notice in writing by the authority of **Kendriya Vidyalaya No.2 EME**, **Vadodara**.
- 19. By virtue of this agreement, no relationship will be created between the Conservancy staff/ Workers and **Kendriya Vidyalaya No.2 EME, Vadodara**. It will be the sole responsibility of the Service Provider to pay salary and other perks to its Security Guards/ Gardner / Conservancy staff/ Data Entry operator meeting all statutory obligations and no complaints by any of its Security Guards/ Gardner /Conservancy staff/ Data Entry operator in this regard will be entertained by the **Kendriya Vidyalaya No.2 EME, Vadodara**.
- 20. The agreement can be terminated earlier by giving one month written notice on Kendriya Vidyalaya No.2, EME Vadodara side and three months" notice on the side of Service Provider without assigning any reason and the decision of the Vidyalaya authority shall be binding on the Service Provider. No claims for compensation of loss/revenues due to such decision shall be entertained.
- 21. The Candidates/Manpower provided by the Contracting Agency shall be accepted only after scrutiny by Kendriya Vidyalaya No.2, EME Vadodara. Therefore, minimum three-four bio-data shall be made available against each slot in each category. The candidate may be invited for personal discussion also. No Conveyance or any other charges will be paid by Indenting Office. In case, none is found suitable then additional bio-data shall be made available by the Contracting Agency, promptly i.e. within 24 hours. The replacement of a Candidate on account of absence /unsuitability for Kendriya Vidyalaya No.2, EME Vadodara, shall be made within 24 hours.
- 22. The workers should be physically and mentally fit. The Security Guard / Gardener / Conservancy staff / Data Entry operator should be neatly dressed up with proper uniform and shoes.
- 23. The Contractor shall get the Security Guard / Gardener / Conservancy staff/Data Entry operator screened for **visual, hearing and major physical defects and contagious diseases** and will provide a certificate to this effect to the Vidyalaya. Only physically fit Security Guard / Gardener

/ Conservancy staff / Data Entry operator shall be deployed for duty by the Service Provider.

- 24. The Security Guard / Gardener / Conservancy staff / Data Entry operator should be well versed with local languages.
- 25. The Service Provider shall be fully responsible and liable for any theft, burglary, fire or any other mischievous deed done by it's Security Guard / Gardener / Conservancy staff / Data Entry operator.
- i) Rates of Remuneration for staff quoted below <u>minimum wages</u> applicable, in the State of Gujarat (name the state/UT) or as per Central Govt. Labour Dept. notification (whichever is higher), shall render the Bid disqualified from evaluation. The wages will be revised as per the statutory notification by the concern govt. authorities and agency must submit the copy of the notification with request to revise the wages from the effective date. Any delay on the part of the agency, they will borne the expenses of paying arrears.
  - ii) The evaluation will be done for all the services put together. Indenting Office will award the contract to the lowest evaluated responsive bidder as a whole.

- iii) The Bid will be treated null and void, if it is quoted with "LESS THAN ONE PERCENTAGE" service charges which should include Profit, providing uniform to all the employees, payment of I.T(2% of the payment), and all other overhead expenses too.
- 27. The said Firm/Agency will be solely responsible in regard to **LEGAL OBLIGATIONS** on Security Guard / Gardener / Conservancy staff/ Data entry operator employed by it and deployed in Kendriya Vidyalaya No.2 EME, Vadodara.
- 28. Verification of **CHARACTER AND ANTECEDENTS** of the Security Guard / Gardener / Conservancy staff/ Data Entry operator through **POLICE is mandatory** and shall be the responsibility of the Service Provider. A declaration on the printed letter-head of the firm, stating inter-alia that the Conservancy staff / Data Entry operator provided are of good character, duly verified by the Police from security angle should be provided to the Vidyalaya immediately after award of Contract. The Security Guard / Gardener / Conservancy staff/ Data Entry operator shall not enter into any unlawful activity within the KV premises and shall have a good moral character.

#### 29. <u>Police Verification Report should be submitted to the Vidyalaya of all the workers</u> engaged at Kendriya Vidyalaya No.2 EME, Vadodara for Conservancy, Gardening, Security and Data Entry operator.

- a) The normal office hours of the Principal, Kendriya Vidyalaya No.2 EME Vadodara are Monday to Saturday 7.00 am to 4.00 pm (except Govt. holidays). However, Kendriya Vidyalaya No.2 EME, Vadodara reserves the right to request the services on Saturday / Holiday / beyond office hours. The Contracting agency will be compensated by the Indenting Agency as per the rate quoted for OTA for working on Holiday / beyond office hours. However, overtime hours in a month will not exceed 54 hours.
  - b) In case of absence on any working day, the monthly remuneration will be regulated as per the following formula:

*Total Monthly Remuneration = Monthly remuneration –A1*

- 31. Losses caused to the Vidyalaya due to negligence on the part of Security Guard/ Gardener/ Conservancy staff /Data Entry operator will be recovered from the Agency/Contractor.
- 32. The Security Guard / Gardener / Conservancy staff /Data entry operator provided by the Service Provider should be well mannered, courteous and polite. The Security Guard / Gardener / Conservancy staff/Data Entry operator should not smoke or consume liquor while on duty and should not play cards, etc. in the Vidyalaya. The Vidyalaya shall not provide any accommodation or living facilities to the Security Guard / Gardener / Conservancy Staff / Data Entry operator.
- 33. During the period of leave of any of the Security Guard / Gardener / Conservancy staff/Data entry operator, the Service Provider shall deploy another Security Guard / Gardener / Conservancy staff/Data entry Operator with prior intimation to the Vidyalaya.
- 34. The Service Provider shall be responsible for complying with obligations under Income tax, ESI, PF, Contract Labour (Regulation and Abolition) Act, Wages Act, Labour Laws, etc. The Service

Provider shall be responsible for complying with obligations for damages to third party arising due to accident, etc.

- 35. All the employees employed should be allotted with UAN number provided by the EPF department within 15 days from the date of contract (01-10-2019).
- The Contracting Agency will provide Identity Card to all his employees deputed as per 36. the format suggested by the Indenting Office valid for the period of contract.
- It will be the responsibility of the Service provider to comply with all statutory obligations on 37. his part arising out of this contract. Minor variations as per actual calculation will be borne by the contracting agency.
- The quoted rates will be all inclusive of all charges, no Service Tax as KV No.2 EME 38. Vadodara is an educational institution, and no other charges will be paid extra.
- 39. The Service Provider shall authorize a person to supervise the cleaning and maintenance service who will report to the designated officer/ Principal of Kendriya Vidyalaya No.2 EME, Vadodara. The Service Provider/ Supervisor shall report to the Vidyalaya as and when he is required by the Vidyalaya authority in connection with the Contract.

#### 40. The payment to the Agency / Service Provider will be made against running bills on monthly basis subject to services being satisfactory.

- The Contracting Agency will ensure payment by the  $5^{\text{th}}$  of every succeeding month to their i) employees provided to the satisfactory work/actual attendance of their employees as per the monthly remuneration and OTA charges quoted without any deduction into their bank accounts or by cheque.
- ii) The Contracting Agency will submit the invoice along with proof of disbursement in triplicate after making the payment to the employees provided to the satisfactory work/actual attendance of their employees supported with the following documents:
  - a) Details of disbursement made to the staff furnishing cheque details / bank deposit details for each payment, Xerox of bank passbook of the worker with every bill.
  - b) Proof of payment of statutory obligation such as EPF, ESI, Service Tax, Xerox of epassbook of every employee monthly and any other applicable tax.
- iii) No payment shall be made in advance. The Service Provider shall submit the bill in the first week of following month in respect of previous month for sanction of the amount of bill and passing the bill for payment. Payment to the Contracting agency will be released within 15 days from the date of the receipt of the invoice along with all the proofs for payments as quoted above. All payments shall be made by cheque / RTGS / NEFT only.
- The Vidyalaya shall be at liberty to withhold any of the payments in full or in part subject 41. to recovery of penalties, if any.
- The Kendriya Vidyalaya reserves the right to order any worker of the Service Provider to leave 42. the premises of the Kendriya Vidyalaya if his/her presence at any time if felt undesirable.
- 43. The selected agency/ Service Provider shall have to execute an agreement on non-judicial stamp paper of **Rs.100**/- to be signed by both the parties.

- 44. In case of dispute of any kind, the firm shall abide by the decision of the Kendriya Vidyalaya No.2 EME, Vadodara. In case the dispute is required to be referred to Arbitration, it shall be referred to sole arbitrator under Arbitration and Conciliation Act- 1996. The place of settlement of dispute shall be Vadodara. In the case of settlements of dispute is in the court, it will be in the jurisdiction of courts at Vadodara.
- 45. Any other provision may be incorporated by the Vidyalaya authority. The same shall also be binding on the Service Provider/ Agency.

#### TERMS AND CONDITION FOR CLEANING / SWEEPING (CONSERVANCY) FOR KENDRIYA VIDYALAYA

# **SCOPE OF WORK**

(The bidder is advised to visit and acquaint himself with the operational system. The costs of visiting shall be borne by the bidder. It shall be deemed that the contractor has undertaken a visit to the Vidyalaya and is aware of the operational conditions prior to the submission of the tender documents)

# H. Daily Work (from 07:00 AM to 12:30 PM and 01:30 PM to 04:00 PM or as may be decided by the Vidyalaya)

- 1. Sweeping of entire area of the school building and surrounding of building and collection of all waste material and disposal of the same as per the instructions of the Principal / Cleanliness Committee / Staff Members.
- 2. Cleaning of the floor area with a wet floor dusters and detergent disinfectants etc, once in the morning before opening of the Kendriya Vidyalaya and thereafter every 2 hours specially in the areas like corridors, stairs and reception etc. spray of flit etc. in the rooms for keeping the rooms free from mosquitoes, flies etc.
- 3. Cleaning and washing of toilets and urinals using deodorants, detergent and disinfectants once in the morning and again in the afternoon or as may be specified by the Principal.
- 4. Cleaning of carpets, Durries etc.
- 5. In case of shortage of water or non-availability of water, brining water from outside for cleaning.
- 6. Sweeping and cleaning of open areas, roads, passage, lawns etc. within the boundary of the Kendriya Vidyalaya.
- 7. Regular dusting/cleaning of furniture (table and chair) and equipments, telephones, book cases, filling cabinets, almirahs and doors and windows in class- rooms, all other rooms and other spaces of the school every day before opening of the school.
- 8. The choking of the sanitary installations e.g. Traps Bottle traps, gully traps etc. is to be cleared within 24 hours of noticing the complaint.
- 9. All complaints of leakage in the Gl & Cl pipes etc. are also to be attended within 24 hours.

### B. Items of work to be done generally once in a week

- 1. Washing and scrubbing of floor areas with detergents and dirt removing agent.
- 2. Acid cleaning of sanitary wades, without damaging their shines.
- 3. Removing stains from floor, doors and partitions by using surf or any suitable detergent as are found necessary without leaving any undesirable post cleaning marks.
- 4. Cleaning of filled surfaces in the corridors and staircases.
- 5. Cleaning of water storage tanks and water coolers, if any.
- 6. Polishing of brass name plates and number plates and cleaning of all other name plates/ Boards
- 7. Dusting and cleaning of fans, electrical fittings, window panes with glass cleaning chemical/agents and cleaning of partition paneling etc.
- 8. Removal of cobwebs in all rooms and other spaces of the school.

# C. Requirements from staff of the Agency their duties and behavior etc.

- 1. The contractor shall comply with all the laws and regulations applicable in the matter of such workers as are engaged by it.
- 2. The contractor's staff shall not disturb the employees of the Kendriya Vidyalaya or make any sort of noise in the school premises.

### DEFINITIONS

The agreement is general in nature wherein the particular office has been generally referred to as "INDENTING OFFICE" and the agency providing the service as "CONTRACTING AGENCY". If desired the word "INDENTING OFFICE" may be substituted by the acronym of the particular office and the CONTRACTING AGENCY by a suitable abbreviated name/acronym.

#### **1.2 PREAMBLE**

### **1.5 MODALITIES OF CONTRACT**

- 1.5.1 This contract is of the nature of service contract for a specified period and not labour contract.
- 1.5.2 The responsibility of the CONTRACTING AGENCY and schedule of fulfillment thereof shall be as per Appendix 1 to the Agreement.
- 1.5.3 There will be a Screening Committee for evaluation of progress of the WORK. This Committee shall be set up by the INDENTING OFFICE. It will [fix/indentfy] the work to be done by the CONTRACTING AGENCY, targets/ milestones and criteria for completion of the Work. It shall also review the progress of the WORK at midterm of contract period. If at any state the Screening Committee finds the performance of the CONTRACTING AGENCY unsatisfactory, a notice to that effect will be sent to CONTRACTING AGENCY and if it fails to improve its performance of WORK within seven days of the notice serviced, the continuation of this agreement will be reviewed by the INDENTING OFFICE and agreement shall be terminated by giving information in writing to that effect to the CONTRACTING AGENCY.
- 1.5.4 For the purpose of providing service, the working hours and days of workers deployed by the CONTRACTING AGENCY in the premises of INDENTING OFFICE shall be as per para 2 of the tender document.

### **1.6 RESPONSIBILITIES OF CONTRACTING AGENCY**

1.6.1 CONTRACTING AGENCY shall undertake the WORK as per schedule detailed in Appendix - 1 to the Agreement by providing manpower including material in the premises of the INDENTING OFFICE.

- 1.6.2 This period of completion of WORK will not be extended unless it is for the reason beyond the control of the CONTRACTING AGENCY for a period not exceeding six months.
- 1.6.3 CONTRACTING AGENCY shall substitute suitable workers in lieu of those provided by it in the INDENTING OFFICE for the purpose of WORK, if not found suitable by the INDENTING OFFICE on initial evaluation within 48 hours of written notice. Similarly the INDENTING OFFICE will continue to hold the right to reject the replacement provided and ask for substitutes in cases of absentees / sick workers or otherwise on valid reasons.
- 1.6.4 CONTRACTING AGENCY shall on receipt of advance notice of not less than 24 hours from the INDENTING OFFICE, provide additional manpower or make temporary withdrawal of manpower provided by it.
- 1.6.5 CONTRACTING AGENCY shall be responsible for payment of salary, grant of leave and providing coverage for insurance medical benefits or such other statutory benefits to its workers provided by it in the INDENTING OFFICE. The INDENTING OFFICE shall not be responsible for making any payment to them. Workers provided by CONTRACTING AGENCY shall be employees of the CONTRACTING AGENCY for all purpose and the INDENTING OFFICE shall not have liability of any kind towards workers.
- 1.6.6 CONTRACTING AGENCY shall be responsible for any damage to the property / equipment / material of the INDENTING OFFICE by its personnel during the course of or consequent to the WORK being rendered. [Intimation regarding damage shall be given in writing to the CONTRACTING AGENCY within a week].
- 1.6.7 Liquidated damages for defaults on the part of the CONTRACTING AGENCY will be recovered from it. The decision of the head of INDENTING OFFICE shall be final in this regard.

#### 1.7 **RESPONSIBILITIES OF THE INDENDING OFFICE**

- 1.7.1 INDENTING OFFICE shall provide all the basic working data available with it and afford all working facilities available with it to the authorized workers provided by the CONTRACTING AGENCY for fulfillment of the work.
- 1.7.2 INDENTING OFFICE shall permit the duly authorized workers of the CONTRACTING AGENCY at all convenient times to enter into and upon its premises where work is to the performed.
- 1.7.3 INDENTING OFFICE will maintain a separate record of attendance of no. of workers provided by the CONTRACTING AGENCY. The payment will be released to the CONTRACTING AGENCY on prorata basis after deducting the days of absence without suitable replacement or poor performance.

#### **1.8 COMPLETION**

1.8.1 The WORK shall be deemed to have been completed on expiry of period of this contract and release of final payment to the CONTRACTING AGENCY by the INDENTING OFFICE subject to review by the Screening Committee set up vide provision 1.5.3.

#### **1.9 CONFIDENTIALITY**

#### 2.2 EFFECTIVE-DATE, DURATION, TERMINATION OF THE AGREEMENT
